



## GENERAL AGREEMENT AND LIABILITY RELEASE

**RESPONSIBILITY AND LIABILITY:** I understand that The Ranch for Canine Training and Behavior (“The Ranch”) makes every effort to provide a safe environment for all canine and human clients under their instruction, as well as others within the general proximity of their work. While on the grounds of The Ranch I agree that this is MY OWN RISK. I have researched the skills and credentials of The Ranch and AGREE with their practices, policies and procedures. I understand that all dogs can and do bite. I am aware of (1) the RISK of injury to myself or my dog(s) while in training and (2) that I am responsible for any INJURY, or physical or financial damages caused by my pet(s) to another pet, person or the physical location in which training is conducted.

I will NOT hold “The Ranch” or its agents/associates, outside of gross negligence, responsible should an accident, injury, illness, escape, theft, fire, or death of my pet occur while in their care.

I will NOT seek retribution from The Ranch should an accident, injury, illness, escape, theft, fire, or death of my pet occur during or following ANY services or training.

**VACCINATIONS/OVERALL HEALTH:** I hereby declare that my pet is current within the calendar year on (1) Rabies, (2) DHPP, and have provided vaccination records. I understand that it is my responsibility to keep my pets regularly vaccinated and to provide updated records. I understand The Ranch can refuse services should I fail to do so. I also understand that my dog is still susceptible to other illnesses due to age, stress, nutrition levels, immune system, and exposure to other dogs. I understand that The Ranch requires all dogs in training to be clean, healthy, vaccinated and with no apparent fleas, ticks or worms. The Ranch has the right to refuse training to any dog who appears in physical pain.

**MISCELLANEOUS DETAILS:** (1) I understand that The Ranch is not responsible for misplaced, lost, damaged or broken items during or following ANY services rendered. (2) I understand the rates and payment terms for services as established by The Ranch. (3) I understand that if I am not satisfied with the services provided by The Ranch I will notify them within 2 business days. (4) I understand The Ranch has the right to refuse service to any owner and or pet at her discretion.

**RIGHTS TO PHOTOGRAPHS AND VIDEO FOOTAGE:** I authorize The Ranch the right and permission to use any photographs/video taken of my dog for any purpose and in any media now or in the future.
